1. POLICY AND PRACTICE

National Policing, Health and Social Care Consensus – 7th February 2018

Policing, health and social care organisations agree a national consensus to improve people's health and wellbeing, prevent crime and protect the most vulnerable people in England by:-

- Moving beyond single service-based practice to whole place approaches to commissioning and delivering preventative services in response to assessments of threat, harm, risk and vulnerability
- Getting better at identifying and supporting vulnerable people through the millions of interactions between community members, health and police services and our partners each year
- Enabling partner agencies to work better together to support 'troubled families', domestic abuse victims, children subject to Child Protection Plans and the management of sexual and violent offenders and those with complex dependencies such as drugs, alcohol or mental health.
- Identifying and exploring opportunities where national bodies can promote guidance, promote the sharing of information, support education and training needs and share learning to improve services
- Ensuring staff have the skills and knowledge necessary to prevent crime, recognise risk factors earlier, protect the public, improve health and wellbeing and secure public trust
- Working together to use shared capabilities and resources more effectively to enhance the lives of those with complex needs and the people they interact with
- Offering an integrated approach through the better co-ordination, prevention and early intervention that will increase the reach and impact of all services.

Government plans to make sure that what is illegal offline is illegal online – 6th February 2018

Prime Minister announces plans for the Law Commission to review current legislation on offensive online communications to ensure that laws are up to date with technology. The announcement, coinciding with Safer Internet Day also included plans for a new social media code of practice to set minimum standards for online platforms and new [guidance for teachers](#) to develop children's online safety skills.

Reducing Crime, Preventing Harm: West Midlands Drug Policy Recommendations – 12th February 2018

PCC David Jamieson publishes recommendations for local drug policy in the West Midlands following a Drug Policy Summit held in December 2017. The report considers government policy, highlights good and effective practice from across the country and identifies a range of policy proposals considered worthy of being 'closely looked at for their ability to reduce crime and prevent harm'.

Putting information sharing at the heart of collaborative working – 7th February 2018

Centre of Excellence for Information Sharing publishes a report for police and health services on sharing information for prevention, early intervention and care purposes. The report brings together local examples of collaboration between the Police and the health services through improved information sharing and highlights a range of questions for consideration when sharing information

Mental health of adults in contact with the criminal justice system – 13th February 2018

National Institute for Health and Care Excellence publishes a revised quality standard for the mental health of adults in contact with the criminal justice system. The quality standard covers recognising, assessing and managing mental health problems in adults who are in contact with the criminal justice system – including police contact, court and prison custody, street triage, liaison and diversion services, and probation services.

Global CSE Threat Assessment 2018 – 14th February 2018

WePROTECT Global Alliance Partnership publishes the first global CSE threat assessment, which highlights how technology is enabling offenders to attain unprecedented levels of access, new capabilities and increasing confidence to abuse children on a mass scale. The report notes that the growing ownership of mobile devices, expansion of high speed internet and encrypted communications technology which is allowing offenders from anywhere in the world to target children. Individual dark net sites are hosting up to 1million paedophiles, who regularly meet to plan and encourage online abuse and share up to 1.6m files. Increasingly offending is now committed entirely online, with offenders coercing and extorting children into producing indecent images of themselves via webcams. The presence of a video camera on every device and computer has seen peer to peer image sharing make way for the increasing threat of live streaming.

2. RESEARCH, DEVELOPMENT AND STATISTICS

Police trial new Home Office mobile fingerprint technology – 10th February 2018

West Yorkshire Police, in collaboration with the Home Office will trial a new mobile fingerprinting app which will allow frontline officers across the country to use their smartphones to identify people via the new Biometric Services Gateway in less than a minute. 250 scanners will be rolled out to officers over the coming weeks, with a further 20 forces expected to roll out the system by the end of 2018.

New technology revealed to help fight terrorist content online – 13th February 2018

Home Office and ASI Data Science announce the development of new advanced machine learning technology to automatically detect terrorist content on any online platforms. Tests have shown this new tool can automatically detect 94% of Daesh propaganda with 99.9% accuracy and can be integrated into upload processes to stop the majority of video propaganda before it reaches the internet. The Home Office and ASI will be sharing the methodology with smaller companies to help combat abuse of their platforms by terrorists.

The nature of violent crime in England and Wales: 2016/17 – Published 8th February 2018

Detailed findings from the Crime Survey for England and Wales highlight a significant decrease in experience of violent crime in 2016/17 (1.7%) when compared to rates at their peak in 1995 (4.8%), but no statistically significant change over the previous year. Violence without injury accounted for 53% of all CSEW violent incidents, while the higher harm crimes of wounding (24%) and assault with minor injury (23%) accounted for lesser proportion. The survey found that only 43% of victims reported their experiences to the police. Victims believed the perpetrator(s) to be under the influence of alcohol in 40% of violent incidents. A self-completion module asking young people about knife possession found that 5.7% of 10 to 15 year olds and 4.8% of 16 to 29 year-olds knew someone who carried a knife for their own protection. Less than 1% of respondents (0.5%) personally carried a knife. These proportions have shown no statistically significant variation since 2011/12. Sexual offences in England and Wales: 2016/17 – Published 8th February 2018

Detailed findings from the Crime Survey for England and Wales highlight no significant change in the prevalence of sexual assault reported in surveys in 2004/05 (2.6%) compared to 2016/17 (2.0%). Within this figure, however, the prevalence of indecent exposure or unwanted sexual touching has seen a statistically significant reduction from 2.3% in 2014/15 to 1.7% in 2016/17. The survey showed that around 83% of victims did not report their experiences to the police. Around 20% of women and 4% of men are estimated to have experienced some type of sexual assault since the age of 16. Further demographic [data available](#)

Domestic Abuse in England and Wales: 2016/17 – Published 8th February 2018

Detailed findings from the Crime Survey for England and Wales highlight statistically significant reductions in the prevalence of adult domestic abuse between 2011/12 (7.0%) and 2016/17 (5.9%), largely driven by reductions in partner abuse (5.2% to 4.5%) over the same period. The number of domestic abuse victims is estimated to have fallen from 2.7m in 2004/05 to 1.9m in 2016/17. Around 26% of women and 15% of men are estimated to have experienced some form of domestic abuse since the age of 16. Women were more likely than men to have experienced all types of domestic abuse, with the exception of non-sexual family abuse, where the difference was not significant. Fire and rescue incident statistics to September 2017 – Published 8th February 2018

Home Office statistics show FRSs attendances increased by 3% in the year to September 2017, but remain 34% lower than ten years ago. Fire attendances (175,673) accounted for 30% of call outs, marking a 9% increase over the last year, but a 49% decrease compared to ten years ago. FRSs also attended 170,000 non-fire incidents (31%) during the year, up 2% on the previous year and continuing the trend seen since 2014/15, which has been largely affected by a rise in medical incidents attended. The number of fire-related fatalities (346) increased by 37% during the year, largely driven by fatalities linked to Grenfell Tower (77).

Reported road casualties: estimates involving illegal alcohol levels: 2016 – Published 8th February 2018

DfT provisional estimates for 2016 show a 7% rise in overall drink drive casualties of all severities in 2016 and a 6% rise in drink drive accidents of all severities. An estimated 230 fatal drink drive accidents occurred in 2016. General road deaths and casualties meanwhile decreased by 4-5% in 2016, while vehicle traffic levels increased by 1.0%. Criminal Justice Statistics Quarterly: September 2018 – Published 15th February 2018

Ministry of Justice report highlights a 7% reduction in the number of individuals formally dealt with by the criminal justice system over the last year, reaching a record low and continuing the downward trend seen since 2007. The number prosecuted at magistrates' courts fell by 5%, however the overall conviction ratio increased by 1% point to 86%. 3. AUDITS AND INSPECTIONS

PEEL: Police leadership Inspection Reports 2017 – Published 8th February 2018

HMICFRS' annual all-force assessment of police leadership found many examples of police leaders showing drive and commitment to improvement. In almost all forces, police leaders showed that they understand the importance of treating the people they serve fairly and with respect. Leaders were found to generally welcome and value feedback and challenge from their workforce, although more could be done to show their workforces that they had made changes in response to the findings from workforce surveys. The assessment also found commitment from police leaders towards understanding the nature and scale of vulnerability, however, in some areas, forces need to take more action. Other areas for improvement included:-

- Looking outside of the organisation for innovation and new ideas
- Finding future leaders and ensuring the workforce feels that the processes are fair
- Skills and capabilities succession planning - including considering talent from outside policing
- Developing a deeper understanding of workforce skills in order to plan for future demand
- Developing leaders – only 3 forces could prove that all of their staff had been through a recent PDR

The report recommends that forces improve their use of PDR processes, in line with College of Policing guidance, to better understand their people's leadership skills and capabilities. [Force level reports available](#)

Enforcement and Recall – 9th February 2018

HMI Probation thematic inspection finds the overall quality of CRC offender management and enforcement decision-making in community orders, suspended sentence orders and post-sentence supervision to be poor. Levels of contact were not always adequate to meet the individual's needs resulting in CRCs not always knowing when enforcement was appropriate. The report notes that task of building a competent CRC workforce is constrained by the level of resourcing. The inspectorate found the overall quality of NPS assessment, supervision planning case management and enforcement decision making to be good with a positive balance being struck between purposeful work and the use of enforcement to re-engage individuals or to apply controls. Both CRCs and NPS had very limited access to appropriate women only provision and there was inconsistent evidence of CRC staff responding positively to women-specific needs. The report recommends that

- The government ensure that probation services are sufficiently resourced to supervise complex individuals
- HMI Prison and Probation Service set expectations that CRCs and the NPS develop partnership-based approaches with key local stakeholders to manage those released from prison on licence
- CRCs ensure effective assessment and planned and purposeful levels of face-to-face contact with clients
- CRCs and NPS should jointly develop local partnerships that directly address service users' needs in relation to accommodation, health, education and substance misuse and; jointly develop local services which are accessible to those with diverse needs, particularly women.

4. REVIEWS AND INQUIRIES

Justice Committee recommendation additional resources for HMI Prisons – 16th February 2018

Evidence session following an inspection of HMP Liverpool recognises that failings are not limited to one establishment, but symptomatic of shortcomings across the prison estate. The Committee recommends that:-

- HMIP are given additional resources to follow-up on recommendations and hold prisons to account
- Major contracts are subject to a public framework which outlines expectations, performance and penalties
- Annual public notification of where, why and by how much contractors are penalised in such cases
- MOJ and HMPPS publish a plan to resolve the persistent overcrowding of the estate
- MOJ set out how it plans to minimise the risk of gaps between justice and healthcare systems

Currently, under Section 170 of the Road Traffic Act 1988, road traffic accidents should be reported in person at a police station or to a police constable.
