## 1. POLICY AND PRACTICE

### [Apply for funding: Early Intervention Youth Fund – 30 July 2018](#)

Home Office invites funding bids from PCCs, working with Community Safety Partnerships, for projects that steer young people away from serious violence via targeted early interventions and prevention activity. Projects should aim to delivering services to support and prevent young people from getting involved in crime; deliver positive outcomes for young people, focused on addressing risk factors which are linked to serious violence; build on, and developing, our understanding of what works in practice for tackling these risks factors; drive improved local, multi-agency partnership working; and reduce levels of serious violence and crime. The total level of funding available over the two year period has been increased from £11m to £22m.

### [Home Office announces successful bids for the 2018/19 Police Transformation Fund – 1 August 2018](#)

Government announces the [15 Police Transformation Fund projects](#) receiving a total of £42.7m between 2018 and 2020. The funding is in addition to £70m already being invested in the National Enabling Programme (unified IT), the Specialist Capabilities Programme, the Digital Policing Portfolio and Transforming Forensics.

### [£2m extension of the Independent Child Trafficking Advocates scheme announced – 30 July 2018](#)

Home Office confirms a £2m extension of the Independent Child Trafficking Advocates (ICTAs) scheme, which aims to ensure public authority decision making is in the best interests of the children involved in their care

### [Future vision for probation – 27 July 2018](#)

Justice Secretary, David Gauke, launches consultation on the future of probation services, setting out plans to:

- Strengthen offender supervision in existing CRC contracts ensuring new offenders are seen at least monthly
- Invest an extra £22m a year to improve through-the-gate support for offenders leaving prison
- Introduce a standard training framework for probation staff and explore implementing a professional register
- End CRC contracts in 2020 (2 years early) and work to develop a more effective commercial framework
- Align CRC and NPS areas across ten new probation regions in England to improving joint working
- Simplify and strengthen ties with key partners, including the third sector, local authorities and PCCs
- Create opportunities to co-commission rehabilitation services with PCCs

### [Appropriate adult partnership agreement for vulnerable adults in custody – 31 July 2018](#)

Home Office publishes a voluntary framework for PCCs and local authorities working to improve safeguards and access to justice for vulnerable adults in custody through the provision of appropriate adults. The agreement was developed in partnership with the National Appropriate Adult Network, LGA, APCC and NPCC.

## 2. RESEARCH, DEVELOPMENT AND STATISTICS

### [The economic and social costs of crime](#) – 23 July 2018

Updated Home Office report estimates the total economic and social costs of crime in England and Wales to have been around £50bn for crimes against individuals and £9bn for crimes against businesses in 2015/16. Violent crimes make up almost three quarters of the total, with homicide (£3.2m) and rape (£39,360) having the highest estimated unit cost. The total estimated costs of crime against individuals (excluding fraud and cyber-crime) is estimated to have fallen from £75bn in 2004/05 to £44bn in 2015/16 as a result of long term reductions in levels of crime recorded via the Crime Survey for England and Wales.

### [The economic and social costs of modern slavery](#) – 30 July 2018

Home Office research report applies methodology used in 'The Economic and Social Costs of Crime' to the offence of Modern slavery to derive a total estimated cost of modern slavery in the UK of £3.3 to £4.3 bn a year. The profile estimates the individual unit costs of labour exploitation to be around £319,000, average unit cost of sexual exploitation to be around £320,000 and the average unit cost of domestic servitude to be around £390,000. In each case, the average cost to law enforcement stood at around £7,730. It has not been possible to estimate the costs to the criminal justice system via this method.

### [2018 National Rural Crime Survey](#) – 23 July 2018

National Rural Crime Network publishes findings from the 2018 rural crime survey which showed that:-

- 27% of respondents believe their local police are doing a good job – having reduced since the 2015 survey
- Rural communities commonly cite fly tipping (57%) and speeding (32%) as local concerns
- Farmers, young people and working families were most affected by crime and fear of crime, with 69% of farmers and rural-specific businesses having been victims of crime over the past 12 months.

### [Police use of firearms statistics 2017/18](#) – 26 July 2018

Home Office statistics showing a continued (19%) increase in police firearms operations in 2017/18 compared to the previous year. Reflecting trends since 2009, around 84% of all police firearms operations (15,794) involve Armed Response Vehicles. There were 12 incidents in which police firearms were discharged in 2017/18, which was broadly similar to the level in 2016/17 (10). The number of armed officers in England and Wales increased by 3% in 2017/18 to 6,459. This continues the upward trend seen since 2016. [Force level data available](#)

### [National Travel Survey – Self-reported Road Safety Statistics](#) – 26 July 2018

Department for Transport publishes road safety statistics from the National Travel Survey for 2017. Around 4.6% of respondents had been involved in a road accident over the previous 12 months, with 1.0% of respondents having been injured via a road accident. This has reduced from 7.3% and 1.8% respectively since 2007. The police attended 35% of self-reported road accidents in 2017, were subsequently informed of 15% and were not made aware of the accident in around 50% of cases.

### [Prison Performance Ratings 2017/18](#) – Published 26 July 2017

Ministry of Justice annual report shows that 14 (12%) of prisons are now showing exceptional performance. Around a third of prisons showing exceptional performance are Male Open prisons. A further 50 (42%) of prisons are meeting the majority of targets. For 54 (46%) of prisons, performance is a concern, with 15 (13%) showing performance as a serious concern – the highest proportion since 2011/12. [Supplementary tables](#)

## [Safety in Custody Statistics to March 2018](#) – Published 26 July 2018

Ministry of Justice Statistics show continued reductions in deaths (-2%) in prison custody over the last year, but a continued rise in incidents of self-harm (+16%), assaults (+16%), prisoner on prisoner assaults (+16%) and assaults on prison staff (+26%) with, in each case, levels reaching record highs.

## [Disruptive and investigatory powers: transparency report 2018](#) – 23 July 2018

Home Office report setting out the way in which disruptive and investigatory powers are used by the security and intelligence agencies as well as law enforcement to tackle the threats posed by terrorism, organised crime and hostile state activity. The report gives a detailed explanation of the various disruptive and investigatory powers such as stops and searches under the Terrorism Act and proscription of terrorist organisations. It also provides extensive statistical information relating to those powers.

## 4. REVIEWS AND INQUIRIES

### [An assessment of Independent Child Trafficking Advocates: Interim findings](#) – 30 July 2018

Home Office report on the first year of the Independent Child Trafficking Advocates early adopters programme finds that a total of 215 children were referred into the service, most aged 16 or 17. The most common nationality of children referred was British, followed by Vietnamese. Interim findings provide early insights into how ICTAs' work varied between different groups of children.

### [Welfare in detention of vulnerable persons review: progress report](#) – 24 July 2018

Independent follow up review, commissioned on behalf of the Home Secretary, looks in detail at healthcare, caseworking, safer detention, oversight and staff culture, and alternatives to detention.

### [Pressing for progress: women's rights and gender equality in 2018](#) – 23 July 2018

Equality and Human Rights Commission report highlights the risk of reductions in funding for women's services as Britain leaves the EU and calls for a sustainable funding model for refugees and domestic abuse services. The report also calls for improvements in reporting, prosecution and conviction rates for sexual violence and domestic violence crimes, mandatory training for professionals in how to identify and support women affected by FGM and stronger support services for survivors of violence, including specialist support services to BAME women, disabled women and women with complex needs.

Victims' Commissioner's report on the entitlements and experiences of victims of Mentally Disordered Offenders highlights the extent to which these victims feel isolated and unsupported within the system, particularly in view of not having the same entitlements under the Victims Code as other victims.

Home Office announces plans for an independent review of the Modern Slavery Act in order to consider its impact and opportunities to further strengthen the UK's response to tackling the issue. The Home Office also confirmed a £2m extension of the Independent Child Trafficking Advocates (ICTAs) scheme, which aims to ensure public authority decision making is in the best interests of the children involved in their care.

## Inquiries

### [Transforming Courts and Tribunals Report published](#) - 20 July 2018

Public Accounts Committee report concludes that the 1.2 billion courts modernisation programme is hugely ambitious and, as such, the changes will be extremely challenging to deliver. The performance of HMCTS to date shows that it has much to learn if it intends to do everything it plans. The extended timetable has already fallen behind schedule, delivering only two-thirds of what was expected at this stage, and there is still no sufficiently well-developed plan of what it is trying to achieve. The pressure to deliver quickly and make savings is limiting HMCTS's ability to consult meaningfully with stakeholders and risks it driving forward changes before it fully understands the impact on users and the justice system more widely.

And a more serious offence, tried in the Crown Court, would carry a sentence of up to 2 years in prison, with those convicted being placed on the sex offenders register

The Bill aims to ensure victims have the confidence to come forward and report their experiences and includes proposals to establish a Domestic Violence Abuse Commissioner to hold the justice system to account in tackling domestic abuse, define domestic abuse in law, create new domestic abuse civil prevention and protection order regime, ensure that sentencing of abusive behaviour involving children reflects the life-long impact that this abuse can have and [ratify the Istanbul Convention](#) to allow certain offences committed by British citizens anywhere in the world to be prosecuted in UK courts
