## 1. POLICY AND PRACTICE

### [Apply for funding: Child Sexual Abuse: National support services fund – 6 April 2020](#)

Home Office launches £2.4m Support for Victims and Survivors of Child Sexual Abuse Fund for 2021-22 for non-statutory organisations working at a national level to support survivors of child sexual abuse. Service(s) should be offered across at least 3 PCC areas, with higher scores being awarded for reaching significantly larger areas. There are no restrictions on the type of service that the fund can support, but this could include support lines, online resources, evidence-based telephone and online counselling services, support groups and services targeting specific hard to reach groups. The deadline for applications is 28 May 2020.

### [Extra £750m coronavirus funding announced for frontline charities – 8 April 2020](#)

The Chancellor announced an additional £750m for charities providing key services to the most vulnerable in society during the Covid-19 crisis. £360m will be directly allocated by government departments while £370m will be made available for small and medium-sized charities, including grants via the National Lottery Community Fund. Charities providing services for victims of domestic abuse and their families and vulnerable children will be eligible for the funding. Government departments are identifying priority recipients and the application system for the National Lottery Community Fund grant will be launched in the coming weeks.

### [Home Secretary launches a new domestic abuse awareness raising campaign – 11 April 2020](#)

Home Secretary launches the #YouAreNotAlone campaign to raise awareness of the services available to support those at risk of, or experiencing domestic abuse. The campaign encourages the general public to show their solidarity and support for those who may be suffering domestic abuse, by sharing government digital content or a photo of a heart on their palm. The campaign also publicises the free phone 24 hour National Domestic Abuse Helpline number – 0808 2000 247 – run by Refuge, and [www.nationaldahelpline.org.uk](http://www.nationaldahelpline.org.uk). The Home Secretary also announced an additional £2m to bolster domestic abuse helplines and online support.

### [Home Secretary outlines how the COVID-19 virus is impacting upon crime trends – 11 April 2020](#)

Home Secretary's address as part of the Government's daily Coronavirus update considers the impact the virus is having on crime. While total police recorded crime has fallen, the risk among some vulnerable and isolated groups has increased, particularly with regard to fraud, online child sexual abuse and domestic abuse. The address highlights how coronavirus-related fraud has already led to losses to victims of over £1.8m, while calls to the National Domestic Abuse Helpline have risen by 120%. The Home Secretary also confirmed that the government are "looking at alternative accommodation to best support the work of refugees at this difficult time".

# Commissioner's e-Briefing: 20 April 2020

## [Prisoner Early Release Scheme](#) – 4 April 2020

Ministry of Justice announces plans for the temporary early release of prisoners with two months or less left on their sentence as part of the national plan to limit the spread of Coronavirus. Only low-risk offenders, within weeks of their release dates will be eligible. The offenders will be electronically tagged, temporarily released on licence in stages and recalled at the first sign of concern. The releases will be phased over time but will start from the week commencing 13 April 2020. Violent and sexual offenders and those of security concern will not be considered for the scheme. The [Parole Board](#) also clarified that prisoners whose release is a Parole Board decision will not be eligible for the scheme. Additionally, the Justice Secretary granted temporary release of [pregnant women in custody](#), while movements between jails have been limited in all but exceptional cases.

Ministry of Justice announce first wave of 500 temporary prison cells to help limit the spread of Coronavirus alongside ongoing work to provide early release of low-risk offenders,

## [Temporary suspension of the 45 day limit on Modern Slavery Safe Accommodation](#) - 6 April 2020

Government suspends the 45 day limit on government-funded safe accommodation for those being supported through the modern slavery victim care, allowing victims and potential victims to remain in accommodation over the next three months. This forms part of measures to protect vulnerable people from coronavirus. The policy will be reviewed at the end of June 2020.

## 2. RESEARCH, DEVELOPMENT AND STATISTICS

### [Policing the COVID-19 Lockdown – What the public thinks – 8 April 2020](#)

Crest Advisory publish findings from their YouGov poll showing that 42% of the UK public fully support the current police approach to enforcing the COVID-19 lockdown, rising to 46% among women and falling to 35% among young people aged 18 to 24. A further 32% supported the current approach, but felt that the police had, in some cases, gone too far. Only 14% of respondents wanted the police to take tougher action. The survey also asked respondents how comfortable or uncomfortable they were with a range of police tactics, including:

- Use of 'stop and account' powers for those not at home (82% comfortable; 14% uncomfortable)
- Issuing fines to people who breached the lockdown (75% comfortable; 19% uncomfortable)
- Arresting people who fail to comply with instructions to return home (72% comfortable; 22% uncomfortable)
- Using of roadblocks asking motorists to justify their journeys (70% comfortable; 24% uncomfortable)
- Asking people to report others who breach the rules (51% comfortable; 42% uncomfortable);
- Using facial recognition in public places to lockdown breaches (50% comfortable; 42% uncomfortable)
- Using drones to photograph people making unnecessary journeys (50% comfortable; 43% uncomfortable)
- Analysis of social media accounts to identify lockdown breaches (43% comfortable; 48% uncomfortable)
- Naming and shaming people on social media (38% comfortable; 54% uncomfortable).

### [Justice responses to COVID-19 around the world – 3 April 2020](#)

Centre for Justice Innovation launches a weekly tracker of the justice system response to the COVID-19 outbreak across different regions of the world. The tracker details of contrasting approaches to areas of justice including the criminal courts, community sentences and community supervision and releases from prison. It finds a pattern of certain services being paused and others adapting and adopting new innovative approaches. The tracker will be updated on a weekly basis.

### [Suicide death registrations in England – 8 April 2020](#)

ONS publish quarterly suicide death registrations between 2001 and 2018 alongside provisional data for 2019. Provisional data indicates that the suicide death rate reached the highest level since 2001 during October to December 2019, having increased incrementally throughout the year. Around 5,248 suicide deaths were registered during 2019 compared to 5,021 in 2018. Suicide death rates per 100,000 persons remain significantly higher among males (17.0) than females (5.9)

### [Sowing the Seeds: Children's experience of domestic abuse and criminality – 1 April 2020](#)

Victims' Commissioner report exploring the overlap between children's experience of domestic abuse and children's offending behaviour makes recommendations for earlier intervention and more consistent practice. The findings suggest this should not be regarded as a short-term problem. The impact of domestic abuse on children will be huge and far reaching.

#### Short Home Affairs Committee inquiry into Home Office's preparations for and response to Covid-19

### [Home Office preparedness for Covid-19: Policing](#) – 17 April 2020

Home Affairs Committee concludes that the police are adapting quickly and effectively to challenges in upholding the new Coronavirus Regulations and welcome the strategy to engage, explain and encourage before considering enforcement. The [inquiry](#) notes some early problems and errors in enforcement, largely affected by the pace at which the new regulations were implemented, but notes the subsequent provision of further guidance and swift clarifications and apologies from forces affected. The report recommends that:-

- The NPCC and the College of Policing should collate and publish figures for use of new enforcement measures by all UK forces on a weekly basis and monitor where there is significant divergence in the use
- All forces and all officers understand the distinction between Government advice and legal requirement, and that the tone and tactics they use are appropriate to each case
- Parks and green spaces are important during lockdown, especially for those who don't have gardens or outdoor space. Enforcement action against those flouting social distancing regulations should be prioritised over universal action by police forces and local authorities to close parks and green spaces to everyone
- Police officers must be an early priority for COVID-19 antigen testing in order to increase their availability and the amount of support they are able to provide to the public. The Home Office should also explain if police forces will be required to purchase their own tests once they become available
- Home Office and NPCC should ensure there is a secure and robust supply chain for PPE—including building in extra supplies both locally and nationally to ensure forces can cope with surges in demand,
- The NPCC must immediately work with Public Health England, the Health and Safety Executive and any other appropriate bodies to address any confusion resulting from inconsistencies in guidance issued to officers about the appropriate use of PPE
- Spit guards must be made readily available to forces where chief constables require them. All forces should write to the committee to explain their policy for providing spit guards to frontline officers during the outbreak.
- Police officers must get the support they need both to respond to mental health cases and look after their own mental health during this crisis. Forces should have the resources to be able adequately to support officers who have had to deal with traumatic incidents, including attending deaths resulting from COVID-19
- The Home Office should immediately addresses the discrepancy in s7 of the Coronavirus Act 2020, and list special constables amongst the types of volunteers employers are compelled to release on full paid leave should they be needed to report for duty by their chief constable
- The Government should review which workers in the criminal justice system have not been afforded key worker status, and consider extending the status to them
- The Home Office, NCA and NPCC set out what action they are taking to address COVID-19 related online fraud in the short term. As per previous Home Affairs Committee recommendations, it is imperative that the Home Office overhauls and modernises action against online fraud.

A further call for evidence on concerns relating to the increased risk of domestic abuse has been issued with a view to producing a further short, specific report over the coming weeks.

NCA Annual plan summarises findings from the [National Strategic Assessment of Serious and Organised Crime](#), published 3 April 2020, alongside the strategic and operational priorities of the NCA and details of how their success will be measured. The NCA's strategic priorities are to:-

- Reduce the number of victims of exploitation: this includes Child Sexual Abuse and Exploitation, Modern Slavery and Human trafficking and Organised Immigration Crime
- Reduce the impact of serious and organised crime on communities, particularly firearms and drugs, and to
- Reduce the harm to individuals, the UK Economy and Institutions from economic crime – the main threats under this includes money laundering, fraud, and cybercrime.
