1. Legislation

Employment Tribunal to Judge the legality of A19

An Employment Tribunal is to hear an allegation that the Force's use of Regulation A19 was illegal in that it contravened age discrimination legislation. The ET, to begin on 4 February in London, is being brought by the Superintendents Association of England and Wales and the Police Federation against five Police Forces which employed A19 in recent years.

The five forces involved in this litigation, and denying the claim, are Devon and Cornwall Constabulary, Nottinghamshire Police, North Wales Police, South Wales Police and West Midlands Police.

[Powers of entry review - WMS](#): The Protection of Freedoms Act (POFA) 2012 requires Ministers across government to undertake a review of powers of entry over a two year period due to conclude in early 2014. The Act requires Ministers with responsibility for powers of entry to examine their powers and to consider whether they are still necessary, proportionate and contain sufficient safeguards.

3. Reports

The Justice Secretary, Chris Grayling MP: Stated that the Government should not pay higher fees for senior lawyers to defend criminal cases when there are competent junior lawyers available for cheaper legal representation fees. Mr Grayling has said that the current £1 billion bill spent on legal aid for criminal cases is too high when budgets across Government are being squeezed ([Telegraph](#)).

Liberty condemns "State-sanctioned abuse": In the High Court some extraordinarily brave women were told that their human rights claims against the Metropolitan Police will have to be heard in the secretive Investigatory Powers Tribunal. These women were all the subject of undercover policing that involved sexual encounters with police officers - in many cases these encounters became long term intimate relationships. Youth Contract opened up to help more young people: The scheme has now been extended to young people aged 16-17 years old who are or were in care; have one GCSE grade A-C and young offenders released from custody. The scheme for those who are not in education, employment or training (NEET) is part of the Government's Youth Contract, which was launched in July 2012.

[Crime Survey for England and Wales:](#) identifies that crime continues to fall, down eight per cent in the year ending September 2012 according to the latest Crime Survey, and is now at the lowest level since the survey began.

A third sector organisation was awarded £150,000 on 23 January to help voluntary groups play a leading role in cutting crime and reducing reoffending.

4. Consultations

Strict new code to prevent powers of entry being abused: Strict new guidelines are to be established to prevent public bodies abusing powers to enter homes and businesses. Home Office minister Lord Taylor announced a new code of practice would be set up and launched a six-week consultation to consider what it should include. There are currently around 1,300 powers to allow public bodies to enter private homes and businesses to enable investigations to be carried out. www.parliamenttoday.com

The Independent Commission on Mental Health and Policing: Launched a public consultation on mental health and policing in reference to the Metropolitan Police Service (MPS) in London. Sentencing guidelines for sexual offences : The Sentencing Council is consulting on a new guideline for sentencing sexual offences and needs the views of those who are affected by, or concerned with, this type of offending. Community Remedy consultation: This consultation seeks views on proposals to introduce legislation to allow police and crime commissioners (or the relevant local policing body) to give victims of low-level crime (such as low-level criminal damage and low-value thefts) and antisocial behaviour a say in the punishment of the offender. Contempt of court: The law governing contempt of court is vast. Several specialist textbooks devote hundreds of pages to the topic. Youth Justice Board Triennial Review: The Government's response to the Public Administration Select Committee report '*Smaller Government: Shrinking the Quango state*' sets out the plans for reforming public bodies. It includes new Triennial Review requirements for Non-Departmental Public Bodies (NDPB). Measuring Child Poverty: During the summer, the Government announced it would consult on developing better measures of child poverty which include income, but provide a more accurate picture of the reality of child poverty today. This consultation asks how we can best reflect the reality of child poverty using a multidimensional measure. A number of potential dimensions are proposed: income and material deprivation, worklessness, unmanageable debt, poor housing, parental skill level, access to quality education, parental health and family stability. Closing date 15 February.
