The Prime Minister David Cameron will today announce new restrictions on access to benefits for new migrants. Mr Cameron will announce a series of measures, including limiting new migrants from receiving out-of-work benefits for the first three months and preventing new migrants from being able to claim housing benefit immediately ([F.T.](#); [Telegraph](#); [Times](#); [Guardian](#); [Independent](#); [Mail](#); [Sun](#); [Mirror](#); [Express](#); [BBC Online](#); [City A.M.](#)).

Official figures from Eurostat have shown that Britain hands out a quarter of all new EU citizenships. More than 177,000 immigrants became UK nationals in 2011, with the top three countries of origin being India, Pakistan and Nigeria. ([Express](#); Mail, print only).

Data released by the Office for National Statistics has shown that immigration to the UK fell in the year to June 2013, but the net immigrant total increased to 182,000 ([BBC Online](#)).

[Lords debate on Police: Public Trust - Nov 28](#)

The debate centred on issues that have undermined public trust and confidence in the police. Several members spoke of the ongoing issue of disproportionate stopping and searching, and how this has affected relations between the police and black and ethnic minority groups. The reputational damage caused by high profile cases of organisational failure and malpractice was also raised.

[Officer numbers 'may decline to 1980s levels'](#)

Concern is mounting that policing could “fall over” as officer numbers threaten to fall to levels not seen during the 1980s coupled with a mounting crisis in morale. Ian Pointon (pictured), Chairman of Kent Police Federation, told a branch open meeting that officers are already “breaking point” – and workloads were taking a grievous toll on them.

[Launch of Independent Police Commission Report by Lord Stevens](#)

There is a The Rt.Hon.Yvette Cooper MP, Shadow Home Secretary, set the task at a time when the police service in England and Wales faced unprecedented change, not least the severe cuts in budget and the Government's reform agenda. The review, led by former Metropolitan police commissioner Lord Stevens, calls for a register of chartered officers, with those found guilty of serious misconduct struck off. It focuses on a commitment to neighbourhood policing, including guaranteed response times to reported crimes.

It shows the increasing complexity of a service which must deliver neighbourhood policing, maintain public order, develop effective counter-terrorism structures, look after victims and adapt to new forms of crime, all with fewer resources.

Human Trafficking: UK responses - examines the UK responses to human trafficking, including the Government's strategy and implementation of the Council of Europe Convention Against Trafficking and a related EU Directive.

UK companies must do more to tackle cyber threat - The UK's top companies are not considering cyber risks in their decision making, a new survey has revealed.

Co-ordinating the policing response to domestic abuse – The College of Policing is launching the next phase of its ongoing work to join up the policing response to domestic abuse.

Police forces reject G4S framework

An alliance of three police forces will not proceed with the outsourcing framework with G4S as a supplier, it has been decided. Bedfordshire, Cambridgeshire and Hertfordshire forces were considering joining Lincolnshire's framework for outsourcing the forces' organisational support services, including human resources, ICT, finance, estates and facilities, fleet, procurement and resource management. The framework was awarded specifically for Lincolnshire's needs following a competitive process, with an option for named forces to join the contract without a new procurement process.

Determined, realistic and focused – local public service in the words of its leaders

Determined, realistic and focused provides analysis of the pressures, challenges and priorities on our local public services, Deloitte commissioned Ipsos MORI to capture the attitudes of the people who run them. Ipsos MORI interviewed executive leaders from across the spectrum of local public services, including council chief executives, directors of education and children's services, NHS chief executives, and police chief constables in every region, together with senior leaders in the devolved administrations. The results provide a fascinating snapshot of local services during a profound period of change.

Clare's law to become a national scheme

A scheme allowing police to disclose to individuals details of their partners' abusive pasts will be extended to police forces across England and Wales from March 2014, Home Secretary Theresa May has announced. It follows a successful 14-month pilot in four police force areas, which provided more than 100 people with potentially life-saving information.

Concordat agreed between the College of Policing and Her Majesty's Inspectorate of Constabulary.

Both organisations have complementary statutory purposes and different powers by which these purposes are achieved. This concordat specifies the common understanding and intended approach of each body in its relation with the other in respect of their roles and responsibilities.

The G8 meetings have developed a consensus to share more information on the emergence of new substances, their impact on public health and the supply routes. The United Nations Office of Drugs and Crime has launched its global Early Warning Advisory to facilitate this exchange and the UK government will continue to work with partners to ensure it is used effectively.

An innovative scheme designed to help reduce the number of motorcycle deaths has scooped 2 prestigious awards recognising safety, Transport Minister Robert Goodwill has announced. The government's safety helmet assessment and rating programme, known as SHARP, has been given a Prince Michael International Road Safety Award and the International Motorcycling Federation's annual Road Safety Award.

Funding streams provided by the Home Office to local areas for crime reduction and prevention have frequently been multi-purpose, with discretion given to local areas as to how to use funds to achieve desired outcomes. Alongside the main police grant, for 2013-14 a transitional Community Safety Fund of £90 million (which comprises some previously separate funding streams) has been established to assist Police and Crime Commissioners in funding local crime and policing projects. In addition, in 2013/14, £400,000 has been provided to fund Advocates for young people, and £700,000 provided to tackle knives, gangs and youth violence (neither of these schemes was running in May 2010).

The Ministry of Justice has revealed that specialist prison officers have been called in to almost half of prisons to deal with hostage-taking, violence and other serious incidents.

The specially trained team was sent to prisons in England and Wales 151 times in the first 8 months of this year, compared with 129 callouts for the whole of last year ([Guardian](#); [Mirror](#)).

Thirty-five potential bidders want to go head-to-head next year to win a share of coveted rehabilitation contracts across England and Wales, Justice Secretary Chris Grayling has announced.

Lord Neuberger, President of the Supreme Court, has said that short jail sentences risk interfering with the home lives of criminals. Lord Neuberger suggested that that sentences as short as two months were not enough to deter prisoners from continuing to commit criminal offences ([Times](#); [Mail](#)).

A survey conducted by the Chartered Institute of Personnel and Development (CIPD) has found 65 per cent of employees on zero contract hours are happy with their work-life balance, compared to 58 per cent of those on regular contracts. The CIPD said that the findings showed that zero contract hours provided the necessary flexibility for workers and employers ([Guardian](#); [BBC Online](#); [City A.M.](#)).

Data released by Ernst and Young (EY) has found that approximately 60 multi-national companies are considering relocating either their global headquarters or a regional headquarters to the UK in the next 18 months. John Dixon, Head of Tax at EY, said that "The controlled foreign companies reforms; changes to the headline rate of corporation tax; and a patent box regime that encourages intellectual property ownership, are increasing the UK's ability to compete for inward investment" ([Telegraph](#); [City A.M.](#)).

The OECD has called the UK's pension reform programme one of the most comprehensive in the developed world.

The report has said the UK's programme has successfully raised pensioners' average incomes while other countries have focused on tackling the growing burden of future pensions costs by raising the state pension age or improving incentives for older people to stay in work ([Guardian](#)).

[More than 22,000 troubled families 'turned around' with intensive help](#)

England's troubled families are getting "back on track", the government has announced halfway through the programme. Over 62,000 families are being worked with, with more than 22,000 "turned around" so far. This success includes getting children back into school, reducing youth crime and antisocial behaviour, with 1,400 adults now in continuous work.

[Government publishes HS2 Hybrid Bill](#)

The Hybrid Bill for HS2 has now been published, giving the government the power to construct and operate the new railway. The DfT has also published the environmental statement for phase one of the scheme linking London Birmingham, with construction expected to begin in 2016/17.

The Chancellor of the Exchequer, George Osborne MP, has announced a cap on payday loan interest rates.

The Financial Conduct Authority currently has the ability to cap the cost of payday loans, and will be obligated to use this ability under these changes to the Banking Reform Bill ([FT](#); [Telegraph](#); [Guardian](#); [Independent](#)).

[Science centre partnerships to boost research](#)

Investment of £350m for 70 new centres for doctoral training has been announced to train over 3,500 postgraduates in engineering and science. The centres are funded by the Engineering and Physical Sciences Research Council (EPSRC) and will involve a total of 1,000 partners, including universities, industry and business.

[Serco prison bid cancelled due to over-charging accusations](#)

The government has cancelled plans to privatise three prisons in South Yorkshire, as the leading bidder is accused of over-charging for electronically tagging criminals.

[Disability 'strongly related' to deprivation – ONS](#)

Disability in England and Wales varies significantly by local authority, [statistics](#) from the ONS suggest. Figures from the 2011 Census show that 12% of residents in Wales reported their day-to-day activities were 'limited a lot', compared to less than 9% in England. In England, the highest percentage of people living with a disability was in Knowsley, Merseyside, compared to just 5% in Elmbridge, Surrey. Merthyr Tydfil, in Wales, had the highest proportion, with 17% of men and 16.6% of women with limited daily activities. The ten local authorities with the lowest percentages were all clustered around an area to the south and west of London. The largest inequality was found at the ages of 65-74, and is strongly related to the level of deprivation experienced by residents in different areas.

[Skills Commission calls for one system for education and training](#)

Educational reforms have failed to provide a coherent system, the Skills Commission has warned. In a new report, [One System, Many Pathways](#), it calls for the DfE to undertake a full review of the available support for education and training.

[Conditional allowance should replace youth benefits – IPPR](#)

Young NEETs should be denied unemployment benefits unless they are involved in "purposeful" training, or an "intensive" search for a job, a new [report](#) has proposed. The Institute for Public Policy Research (IPPR) suggests that a new youth allowance of £56.80 a week should be introduced to replace existing benefits for 18-24 year olds not in education, employment or training. The allowance would be conditional on searching for a job and would be means-tested based on parental income.

Tim Kelsey, NHS Director for Patients and Information at NHS England, has said that a "TripAdvisor-style" review and feedback website for the NHS will be rolled out nationally next year. A three month trial of "Care Connect" has been in operation in London and the north-east, and Mr Kelsey said that some serious issues have already been tackled using the system ([Guardian](#)).

[Legislative Reform Order: Changes to entertainment licensing](#)

This consultation is about implementing reforms to entertainment licensing via a Legislative Reform Order. It sets out proposals to amend the [Licensing Act 2003](#) so that certain entertainment activities in defined circumstances no longer require a licence before they can take place. The consultation closes on 17 December 2013.

Government ministers have announced a public consultation to decide on pension scheme charges, expected to cap management fees charged by pension providers at around 0.75 per cent.

The Financial Secretary to the Treasury, Sajid Javid MP, said the plans would ensure "someone's saving will deliver the biggest possible returns and not be eaten away at by a variety of charges and fees" ([F.T.](#); [Telegraph](#); [Times](#); [Mail](#); [Mirror](#); [BBC Online](#); [City A.M.](#)).

[Ministry of Justice Consultation on Transforming Management of Young Offenders](#)

The Ministry of Justice (MoJ) has today launched a consultation into proposals on changes to the way young adult offenders are managed in custody and access support and services to reduce their reoffending. Consultation closes 13 December.

[Transforming management of young adults in custody](#) - The Government believes that the context in which young adults are managed in custody has changed and therefore is proposing a new approach to managing young adults that takes into account the challenges of this age group as well as ensuring they benefit from wider reforms. The consultation closes on 19th December.

5. Reviews and Inspections

[HMIC: Freeing Up Police Time](#)

Following a review of the progress made with the issues raised in HMIC's 2010 report [Stop the Drift](#)¹, HMIC intends to scope an inspection to identify what else might be done to reduce unnecessary burdens on forces. This will include (but not necessarily be limited to) an examination of how police efficiency and working practices should be improved through the use of modern technology. The on site inspection will take place on 2-5 December 2013.

Her Majesty's Inspectors of Constabulary (HMIs) routinely monitor the performance of all police forces to identify apparent issues for closer scrutiny, ensure emerging problems with efficiency and effectiveness are spotted quickly, and problems are resolved quickly with Chief Constables and local policing bodies.

[HMIC: Domestic Violence](#): On 9 September, the Home Secretary commissioned HMIC to look at the effectiveness of the police response to cases of domestic violence and abuse.

¹ In this joint review, HMIC and HM Crown Prosecution Service Inspectorate (HMCPSP) found that while significant effort has been made in recent years to improve efficiency in both the custody and criminal justice process, there are still a number of issues identified in past reports on this subject which continue to generate delays in processing cases.

Started for Nottinghamshire on the 4 November. This is a Home Secretary commissioned Thematic due to be completed by April 2014.

CJJI: Child Protection Arrangements. In June 2013, the HMIC Board agreed a series of child sexual exploitation related inspections to be conducted over the next three years.

HMIC: National Thematic Review – Automatic Number Plate Recognition (ANPR). The scope of the inspection is subject to further development but the focus is in the prevention of crime.

CJJI: National, Thematic Review: Road Traffic Offences Involving Fatalities

In the light of continuing concern about traffic offences involving fatalities, despite the introduction of new offences in 2008, the review will analyse and assess the quality of police/CPS investigation and prosecution of such cases, and the progress made by the CPS following HMCPSP's 2008 review, establish good practice and make recommendations for positive change. Inspection in 2013/14.

CJJI Inspection: Integrated Offender Management (IOM)

IOM provides an overarching framework for agencies to prioritise interventions with offenders of greatest concern in their locality. This inspection is intended to assist in assessing the impact of IOM and disseminating good practice.

HMCPSP Inspection: Statutory Charging

The previous joint report in 2008 highlighted a number of concerns over the efficiency of the operation of the statutory charging scheme (whereby the CPS took over the responsibility from the police for determining whether an alleged offender should be charged in the more serious or contested cases, by virtue of the Criminal Justice Act 2003). With changes in the landscape implemented in 2010–11 and 2012–13, this follow-up was postponed to 2013-14.

HMIC: Crime Data Integrity. This inspection will examine the effectiveness of the police in dealing with reports of crime by members of the public. The scope is subject to development but is likely to build on the findings of HMIC's previous inspections in this area. Scoping work will include consultation with the Crime Statistics Advisory Committee.
