2014-15 saw:

- 85.4% of victims of crime satisfied with the service from the police.
- The majority of people feel that the Police and Council are dealing with local anti-social behaviour and other crime issues; and perception of ASB is at an all-time low.
- Burglary of dwellings reduced by 9.1%, theft from the person by 19.8%, possession of drugs by 8.4%, theft of motor vehicles by 17.3% and bicycle theft by 5.1%.
- ASB down by 33.6% compared to 2011-12 (19,456 fewer incidents).
- The number of non-crime related mental health patients detained in custody more than halved.
- Efficiency savings of £9,497M.
- 69 additional Confiscation and Forfeiture Orders compared to 2013-14, 19.5% above target.
- Officer sickness reduced by 11.14%.

Looking forward

Since 2010, £42m – or 20% of the budget – has been saved, with a further £11m to find this year and £14.6m in 16/17. All in all, it is likely that from 2010-2020 our Government funding will have halved.

It is clear that we will need radical change and fundamental restructure and reorganisation to meet this challenge, and work continues to seek a better funding deal for Nottinghamshire.

MAKING OUR COMMUNITIES SAFER

"Before my election I made six pledges designed to safeguard our communities which shaped the objectives of my first Police and Crime Plan.

My commitment to increase the support available to victims, witnesses and vulnerable people is delivering tangible results. Responsibility for commissioning victims' services now lies with me and those services are tailored according to individual need and I'm pleased to see improved support available to those affected by domestic abuse, hate crime and anti-social behaviour.

Work with local authorities, specialist groups and support organisations, many of whom I have supported financially, is helping to tackle crime and anti-social behaviour. I have also helped to fund activities that help to prevent crime, reduce the impact of drugs and alcohol on our communities, and cut reoffending rates.

Over the last two and a half years we have continued to recruit extra police officers and PCSOs, but further Government-led austerity measures mean this can't continue. It's a fact that the future will undoubtedly be challenging, but I will continue to do everything I can to ensure that the force is appropriately funded and fit for purpose in the coming years."

Turning Talk into Actions

A stronger voice for BME communities

The Commissioner has received an award for "outstanding contribution to racial justice within the City of Nottingham".

Other initiatives have led to:

- BME police officer recruitment up from 4.69% in 2013 to 15.62% in 2014.
- An increase in BME police officer recruitment (15.62% in 2014, up from 4.69%).
- A 22% improvement in disproportionality of stop and search of BME communities from 2011-12 to 2014-15.
- The introduction of body worn video, thanks to a very successful bid to the Home Office for £1.8m of funding.
- Increased confidence in the police.

Helping those affected by Domestic Abuse

- New services include dedicated support for teenagers, additional support for women at medium risk and with complex needs and a McKenzie Friend project.
- Funding was secured to deliver a number of different project to help survivors.
- Research has identified better ways to help repeat victims.
- A county-wide review has driven change and new, co-commissioned, integrated domestic abuse and sexual violence support services will be in place from April 2016.

Tackling rural crime

The Commissioner has worked hard to see crime tackled effectively in rural areas and overseen a programme that includes:

- The introduction of Rural Special Constables.
- A dedicated policing strategy.
- Targeted police operations.
- New ways to keep rural communities informed.
- Work with national and local organisations to identify trends and best practice.
- Development work to set up a dedicated website.



Community Safety Fund

Since his election, the Commissioner has awarded 90 small grants worth over £1m to more than 60 organisations. Positive outcomes include:

- Support for young people at high risk of exploitation.
- Street Pastor schemes sustained.
- A reduction in reoffending.
- Improved safeguarding capacity for people with learning difficulties.
- Improved relationships between the police and young people.

Support for victims

- Improved support and integrated services to help victims cope and recover.
- Tailored support for vulnerable people, victims of ASB and hate crime, and survivors of domestic abuse and sexual crime is helping them to feel safer.

Reducing Drugs and Alcohol Misuse

As part of his Alcohol Strategy and Action Plan, the Commissioner has championed a successful initiatives including:

- Behaviour-changing campaigns like the Drinkaware Campaign which reduced incidents of inappropriate sexual behaviour.
- Community Alcohol Partnerships and initiatives such as Best Bar None, Purple Flag, Pubwatch and Local Alcohol Action Areas (LAAAs) to tackle alcohol misuse and promote responsible drinking.
- Diversionary and prevention measures in the night-time economy include breathalysers, ID scanners, police operations and alcohol support signposting.
- A targeted operation to reduce violent behaviour resulting from cocaine and alcohol.
